This form must be filled in by each Athlete and sent to the FIVB by his/her NF duly signed once during the season at least 30 days before the start of the first tournament in which an athlete wants to participate and regardless if he/she is already registered and eligible to take part to the FIVB for a SWATCH/FIVB World Tour event. One copy via fax (or post) is sufficient for the FIVB records.

THEREFORE I AFFIRM NOT TO BE ON SANCTIONS BY ANY SPORT ORGANIZATIONS. I ACCEPT ANY ANTIDOPING CONTROL BEFORE OR DURING THE COMPETITION, WHICH I ACCEPT ON MY OWN FREE WILL TO UNDERGO WHEN IT IS DONE IN STRICT COMPLIANCE WITH WADA AND THE FIVB MEDICAL REGULATIONS. AGREEMENT BETWEEN

Ms/Mrs./Mr. (Hereinafter the "ATHLETE") National Volleyball Federation of

.....and **FEDERATION INTERNATIONALE DE VOLLEYBALL**, Avenue de la Gare 12, Lausanne 1003 Switzerland (hereinafter the "FIVB")

WHEREAS

The FIVB is willing to accept the enrolment of THE ATHLETE and the later is requesting the right to be admitted into any and all Beach Volleyball tournaments organized by a promoter or/and by an affiliated Association or by the FIVB itself in any part of the world (hereinafter "Official Events") during the period of January 1st to December 31st, 2007.

The FIVB is willing to obtain in exchange for itself and for its licensees the Right to use worldwide THE ATHLETE'S identification in connection with photos, films, videos computer games hereinafter designed as "Licensed Products" in connection or related exclusively to one tournament or to the ensemble of Official Events to which the ATHLETE agrees.

The ATHLETE is willing in exchange to be granted the Right to participate in any and all Beach Volleyball Official Events and have access to the Event inherent rights.

The ATHLETE, the FIVB and its Licensees will abide by this agreement and by the Athlete's Sponsorship Commitment as approved by the Beach Volleyball Council every year.

NOW THEREFORE The parties agree to the following:

"THE ATHLETE Identification" shall mean the name, the image, likeness, visual representation of THE ATHLETE, and any combination of any of the foregoing.

The ATHLETE hereby grants to the FIVB and to its Licensees the right and license to use THE ATHLETE Identification, but it is expressly understood and agreed herein that the Licensee will not use THE ATHLETE Identification for advertisement or promotion (especially on the packaging of its products) in such a way that THE ATHLETE should not appear alone as endorsing the product. Such appearance will have to be negotiated by a separate contract with the athlete.

All Athlete's and FIVB's sponsorship rights and obligations are mutually granted to each other as mentioned herein and in the Athlete's Sponsorship Commitment and they remain the property of the FIVB and/or THE ATHLETE, accordingly. The FIVB and its Licensees understand that THE ATHLETE has reserved the right to authorise others to use THE ATHLETE'S Identification during the contract period.

"Contract Period" for competition and Athlete's Sponsorship commitment shall mean one year but licensees may extend it to two (2) years with the prior agreement of the Athlete.

"Territory" shall mean the World:

THE ATHLETE will give the FIVB, whenever possible, an access free of charge to materials concerning THE ATHLETE such as pictures, movies and the like.

1. PARTICIPATION RESPONSIBILITIES

- 1.1 The athlete is free to enter or not FIVB Official Beach Volleyball events and should not be constrained by any organization to do so or not. In the case of entering, the athlete must respect and abide by the FIVB Regulations, which breach of may lead to the loss of his/her eligibility to take part in any Official national and international Beach Volleyball and Volleyball competitions including, without limitation to, SWATCH/FIVB (Senior) World Championships, FIVB Beach Volleyball International Events and the Olympic Games.
- 1.2 The athlete requiring authorization from an organization other than his/her own National Federation may not enter FIVB Official Competitions, and an athlete taking part in tournaments not authorized by the FIVB, or playing in a foreign country without a previous written invitation from the local National Association commits a serious breach of the FIVB regulations and may be sanctioned with the loss of eligibility as mentioned in the previous paragraph, without any other formality.
- 1.3 The athlete violating any of the above regulations or other reiterated violations might cause the FIVB to impose heavy fines against the athlete involved.
- 1.4 The athlete is expected neither to claim nor to request any payment other than the prize money to be paid by the promoter.
- 1.5 The athlete is responsible for being informed of the starting time of all matches and of being present and ready on time. During the competitions, athletes should also be available for local promotion and conduct kid camps whenever requested by the FIVB for 1hour per day and/or promoter and/or the host National Federation if it does not interfere with their preparation or scheduled matches.
- 1.6 Upon signing the agreement to enter FIVB Beach Volleyball Events the player accepts:
 - a) That his/her participation is based on the rights and obligations between his/her NF and the FIVB established in the FIVB Constitution, Code of Conduct and General Regulations;
 - b) The obligation to submit himself/herself to anti-doping Controls conducted in accordance with the FIVB Regulations
 - c) The obligation to obtain from his/her National Federation or National Olympic Committee, the list of forbidden substances/products enlisted in the IOC Doping Regulations and to accept the disciplinary measures taken by the FIVB.
 - d) To recognize the exclusive competence of the International Court for Arbitration in Sports recognized by the IOC, the FIVB and the National Olympic Committees and, furthermore, waive any right to appeal to a civil court regarding this issue.
- 1.7 To fulfill the terms of the Event's Regulations of the EVENT in which the ATHLETE shall participate.

2. FINANCIAL CONDITIONS

- 2.1 Before entering an FIVB Beach Volleyball Official event, the athlete must present a medical attestation declaring he/she is in good health to participate in Beach Volleyball competitions and state that he/she assumes total responsibility for any health problems that may occur to him/her, except for injuries, during the FIVB Beach Volleyball Official events.
- 2.2 The athlete will be compensated for his/her participation to the Main Draw of Challenger, Satellite, Country vs. Country and Exhibition and on the basis of his/her performance by way of prize money, which will be paid cash by the promoter upon conclusion of the tournament concerned.
- 2.3 He/she acknowledges the right to authorize his/her National Federation or a representative from his/her country to receive prize money payments **on his/her behalf**.
- 2.4 With the exception of prize money, he/she is not expecting to be paid any other money or offered other values, except for the payment of expenses not conditioned upon his/her success in the tournament. He/she will do his/her utmost to provide, by the deadline stated in the Events Regulations, the travel itinerary to the Promoter concerned.
- 2.5 The athlete will be not compensated with any prize money to his/her participation to the SWATCH/FIVB World Championships Under19 and Under21.

3. THE FIVB GRANTS THE ATHLETE THE RIGHT TO:

- 3.1 Use during the competitions the following accessories: visor or cap or hat or headband, sunglasses, therapeutic support braces for knee/elbow (with approval of the control committee), one (1) watch, footwear and /or athletic socks (with referee approval), and a total of two (2) items to be used as follows: one (1) armband (maximum width 10 cm) and one (1) temporary tattoo are allowed to be worn on each arm at the same time OR two (2) armbands or two (2) temporary tattoo are allowed to be worn one on each arm (each item) at the same time. Such armbands or temporary tattoos must be located on the upper arm only.
(Each accessory may have only one (1) manufacturer's logo of max. 20 cm² and only for each side of the towel whenever authorized by the FIVB. No additional logos will be allowed on any other accessories.
- 3.2 Wear his/her own shorts/bathing suit bottom provided that they are in line with Uniforms standards approved by the 2004 FIVB Board of Administration, present the same colour and style as his/her partner.
- 3.3 Have up to a maximum of four (4) personal sponsorship patches (including manufacturer) on his/her shorts/bathing suit bottom located in any position regardless of their sizes.

4. The ATHLETE COMMITS TO THE FOLLOWING:

- 4.1 Not to wear a patch or logo of any other organization except his/her country flag and the FIVB and SWATCH/FIVB World Tour title, and his/her respective name/nickname which are mandatory for the top ranked teams.
- 4.2 To wear the official tank-top/top as distributed by the tournament organizer/promoter and his/her own shorts/bathing suit bottom approved during: warm-ups, competitions, ceremonies and interviews after the match.
- 4.3 Not to alter the official tank-top/top in any way neither to cover the official FIVB identification or local sponsors on the official uniform.
- 4.4 Whenever required, to submit his/her own shorts/bathing suit bottom and any accessories including temporary tattoos or medical braces for approval by the FIVB Technical Supervisor during the Preliminary Inquiry before the tournament and once approved, not to include any new sponsors' logo/name on shorts, bathing suit bottoms, hats, caps, bags, arm pads, head bands, etc., nor to conclude new agreements with companies willing to sign a last minute deal during the event unless specifically authorized in writing by the promoter of the event.
- 4.5 To update his personal data on the FIVB extranet whenever it will be necessary.

5. THE ATHLETE HEREBY GRANTS THE FIVB AND FIVB'S OFFICIAL SPONSORS/SUPPLIERS:

- 5.1 The right to reproduce in computer assisted and computer related games embodied in or on any devise or medium in the form of software, firmware and/or hardware which may be utilized directly or indirectly for the reproduction of visual images with or without sound of FIVB International Beach Volleyball matches, real or simulated.
- 5.2 The right to assign license or transfer the rights and licenses mentioned herein at their sole discretion to any third party.
- 5.3 The right to make use of and show, at its discretion, any motion pictures, video games, magazines including live, taped or filmed television footage or photos of the athlete taken during FIVB Official events without compensation, and hereby waives any right to such compensation for the player, his/her heirs and assignees.
